Funding Opportunity

Funding Opportunity Reminders

The [Robert Wood Johnson Foundation](#) has announced a Call for Proposals for Public Health Services and Systems Research. Studies funded through the call will focus on research projects that examine the organization, finance and delivery of public health services and the subsequent impact on health outcomes.

Approximately \$3.2 million will be awarded in two funding categories:

1) Short-term studies — Grants will provide up to \$200,000 for a maximum of twenty-four months. This category includes qualitative or quantitative studies that use research to explain how elements of the public health system influence the effective implementation of evidence-based public health strategies and/or implementation of public health-primary care integration strategies.

2) Complex and comprehensive studies — a limited number of grants will provide up to \$450,000 for a maximum of thirty-six months. This category includes multistate time-series analyses and other in-depth studies focusing on comparative effectiveness studies that test the impact of alternative strategies for delivering evidence-based public health services and/or public health-primary care integration. Proposals exceeding either twenty-four months or \$300,000 should specify the data collection or analysis steps that justify a longer grant period and larger budget.

Medicaid HCBS Taxonomy Online Training Available

The National Association for State Units on Aging and Disabilities (NASUAD) has completed a new online training module on the Centers for Medicare and Medicaid's (CMS) newly released Medicaid Home and Community Based Services (HCBS) Taxonomy.

The Taxonomy is an orderly classification of a broad range of HCBS services that CMS applies to State waivers (services included in states' 1915(c) Waivers, or 1915(i) State Plan Amendments). While each state and territory has its own method for collecting data, there is currently no common terminology that applies to data collection for home and community based services across all states. A main purpose of the Medicaid HCBS Taxonomy is to provide common terminology nationally; allowing CMS and states to better understand what services are being provided within a state and in comparison to other states.

NASUAD will hold an all-state call in December to discuss states' questions and feedback on the Medicaid HCBS Taxonomy.
