AoA Funds to Support Virginia Caregivers Respite Care

Virginia residents who take care of disabled or chronically ill family members can apply for \$400 to cover the costs of having someone stay with their loved ones while the caregivers take a break. A total of \$179,079 is available for families through the program, which closes July 31.

The program is being administered by the Virginia Department for Aging and Rehabilitative Services. Officials expect 447 families to be helped. The Virginia Department for Aging and Rehabilitative Services is a 2011 Administration on Aging (AoA) Lifespan Respite grantee and the agency also received an expansion supplement grant in 2012. The expansion funds will be used to provide the respite awards.

The newly proposed regulations by the Centers for Medicare & Medicaid Services on the continued implementation of the Affordable Care Act (ACA), involving the 2014 Medicaid expansion and both flexibilities and safeguards being built into the Medicaid program are published in the [Federal Register](#).

CMS Announces New Initiative to Improve Care and Reduce Costs for Medicare

Hundreds of providers selected to participate in the bundled payments for care improvement initiative

Last week, the Centers for Medicare & Medicaid Services (CMS) announced that over 500 organizations will begin participating in the Bundled Payments for Care Improvement initiative. Through this new initiative, made possible by the Affordable Care Act, CMS will test how bundling payments for episodes of care can result in more coordinated care for beneficiaries and lower costs for Medicare.

The Bundled Payments for Care Improvement initiative includes four models of bundling payments, varying by the types of health care providers involved and the services included in the bundle. Depending on the model type, CMS will bundle payments for services beneficiaries receive during an episode of care, encouraging hospitals, physicians, post-acute facilities, and other providers as applicable to work together to improve health outcomes and lower costs.

The announcement included the selection of 32 awardees in Model 1, and marked the start of Phase 1 (January-July 2013) of Models 2, 3, and 4. The awardees in Model 1 will begin testing bundled payments for acute care hospital stays as early as April 2013.

Individuals may submit concept papers at any time. The DentaQuest Foundation reviews these on the 4th Thursday of every month. Two weeks later, authors of successful concept papers will be invited to submit a full proposal. There is no specified amount of funding, as DentaQuest is seeking as wide of a range of ideas as possible. If a concept seems too large for context, DentaQuest will work to modify as reasonable. If an idea/proposal seems smaller than it could be, DentaQuest will also work with authors to expand.

Seminar on *Frail Older Adults: Building a Care System*

When you get older and begin dealing with frailty and other comorbidities, will you want to be treated in the same system that health care has today? Most likely, the answer is no. Those who care for frail elders work hard and have the best intentions, but the system they work in is inefficient and fragmented. Because of this, care becomes increasingly expensive — and more importantly — does not meet patient and family needs.

The [Institute for Healthcare Improvement](#) (IHI) believes there is a better way. There are organizations that have developed and tested novel solutions to this growing problem. IHI will share these tools and best practices through a new two-day seminar called [Frail Older Adults: Building a Care System](#) to be held in Denver, Colorado on March 20-21.

AGID Update

On January 25, 2013, the Administration for Community Living AGing Integrated Database ([AGID](#)) was updated to include the Administration for Community Living’s Administration on Aging’s (AoA) Special Tabulation based on the ACS 2008-2010 Survey data, limited to summary information on disability characteristics only. Nine tables for each of the 50 states plus the District of Columbia and Puerto Rico are included, with three different geography levels of aggregation including state, county, and total U.S.

The topics include summary information for the population 60 years and older and information for persons with sensory, cognitive, and physical disabilities. The tables are accessible in the Data Files section of AGID.

Paying for Dental Care Using Incurred Medical Expenses

Accessing dental care can be especially difficult for nursing home residents. Paying for dental care using Incurred Medical Expenses (IME) helps long-term care residents get dental treatment and allows dental practices to get reimbursed for services. IME is routinely used for eyeglasses and hearing aids, but many people are not aware that it is also available for dental treatment.
