DOJ and HHS Announce Record-Breaking Recoveries Resulting from Joint Efforts to Combat Health Care Fraud

Government Teams Recovered \$4.2 Billion in FY 2012

Attorney General Eric Holder and Health and Human Services (HHS) Secretary Kathleen Sebelius today released a new report showing that for every dollar spent on health care-related fraud and abuse investigations in the last three years, the government recovered \$7.90. This is the highest three-year average return on investment in the 16-year history of the Health Care Fraud and Abuse (HCFAC) Program.

These findings, released today in the [FY2012 Health Care Fraud and Abuse \(HCFAC\) Program Report](#), are a result of President Obama making the elimination of fraud, waste and abuse, particularly in health care, a top priority for the administration.

The success of this joint Department of Justice and HHS effort was made possible by the Health Care Fraud Prevention and Enforcement Action Team (HEAT), created in 2009 to prevent fraud, waste and abuse in the Medicare and Medicaid programs and to crack down on individuals and entities that are abusing the system and costing American taxpayers billions of dollars. These efforts to reduce fraud will continue to improve with new tools and resources provided by the Affordable Care Act.

To fight fraud, waste and abuse in the Medicare and Medicaid programs, the Obama Administration has continuously added new resources and significantly expanded funding for others, including the Administration for Community Living's [Senior Medicare Patrol Program](#) (SMP)—groups of senior citizens who educate and empower their peers to identify, prevent and report health care fraud. In 2012, HHS Secretary Sebelius awarded 54 states and territories with funding to support SMP programs. Last year, these programs taught more than 2 million beneficiaries how to look for Medicare fraud. Since 1997, more than 1.5 million seniors and their caregivers have contacted the Senior Medicare patrol to ask questions or report potential fraud.

More than Valentine's Day: Taking Care of Our Hearts

February is American Heart Month, which makes this a good time to talk about the ways the Affordable Care Act helps us take better care of our hearts.

Right now, heart disease is the leading cause of death in the United States. Every year, it takes the lives of more than half a million Americans: These are

our grandparents, our parents, our siblings, our friends, and our neighbors. Although many people think of [heart disease](#) as a man's problem, women can and do get heart disease. This epidemic kills more women than diabetes, Alzheimer's disease, and lung cancer combined. In the United States, [a woman suffers a heart attack every 90 seconds](#).

The good news is that most of the risk factors for heart disease—including obesity, physical inactivity, high blood pressure, high cholesterol, and smoking—are preventable and controllable. Now, because of the health care law, millions of Americans with private plans can get life-saving preventive services like high blood pressure screening and help to quit smoking, without paying a penny out-of-pocket. And seniors and people with disabilities who have Medicare can now get recommended preventive services like obesity counseling and cholesterol screening free of charge.

The law also invests in programs like the [Million Hearts](#) initiative, which aims to prevent 1 million heart attacks and strokes over five years. And it invests in the [Prevention and Public Health Fund](#), which helps fight the causes of chronic illnesses like heart disease by, among other things, controlling the obesity epidemic, tackling health disparities, and reducing tobacco use.

Administration Issues Notice of Proposed Rulemaking on Recommended Preventive Services Policy

The Obama administration recently issued proposed rules for public comment regarding contraceptive coverage with no cost sharing under the health care law. The proposed rules provide women with coverage for preventive care that includes contraceptive services with no co-pays, while also respecting the concerns of some religious organizations.

The Notice of Proposed Rulemaking reflects public feedback received through the Advance Notice of Proposed Rulemaking issued in March 2012. In addition, these proposed rules are open for public comment through April 8, 2013.

Medicare Regulatory Reforms to Save Millions

Reforms to Medicare regulations identified as unnecessary, obsolete, or excessively burdensome on hospitals and health care providers would save nearly \$676 million annually and \$3.4 billion over five years, through a rule proposed recently by the Centers for Medicare & Medicaid Services (CMS). The proposed rule supports President Obama's call on federal agencies to modify, streamline regulations on business.

The proposed rule is designed to help health care providers to operate more efficiently by getting rid of regulations that are out of date or no longer needed. Many of the rule's provisions streamline the standards health care providers must meet in order to participate in the Medicare and Medicaid programs without jeopardizing beneficiary safety.

The projected savings would be in addition to the savings from [final rules made in May 2012](#) to also reduce burdensome or unnecessary regulations for hospitals and additional health care providers. Those rules are saving nearly \$1.1 billion across the health care system in the first year and are projected to save more than \$5 billion over five years.

National Health Service Corps Expands the Primary Care Workforce

Physicians to practice in communities that need them most

The National Health Service Corps awarded more than \$10 million in funding for loan repayment to 87 medical students in 29 states, the District of Columbia and Puerto Rico, who will serve as primary care doctors and help strengthen the health care workforce, Department of Health and Human Services Secretary Kathleen Sebelius recently.

Made possible by the Affordable Care Act, the National Health Service Corps' Students to Service Loan Repayment Program provides financial support to fourth year primary care medical students in exchange for their service in the communities that need them most.

The Department of Health and Human Services Secretary Health Resources and Services Administration's (HRSA) Students to Service pilot program provides loan repayment assistance of up to \$120,000 to medical students in MD and DO programs in their last year of education in return for their commitment to practice in the communities that need them most upon completion of their primary care residency.



FDA Offers New Guidance on Developing Drugs for Alzheimer's Disease

Draft proposal focuses on treatments for the early stage of the disease

On February 7th, the U.S. Food and Drug Administration (FDA) issued a proposal designed to assist companies developing new treatments for patients in the early stages of Alzheimer's disease, before the onset of noticeable (overt) dementia.

The draft guidance titled, "[Guidance for Industry, Alzheimer's Disease: Developing Drugs for the Treatment of Early Stage Disease](#)," explains the FDA's current thinking about the way researchers can identify and select patients with early Alzheimer's disease, or those who are at risk of developing the disease, for participation in clinical trials. In recent years, the research community has tried to find ways to identify these patients using criteria that are based on biological indicators (biomarkers). Researchers have also tried to develop sensitive clinical measures that can detect subtle mental decline.

FDA is seeking public comment on the draft guidance for 60 days. Instructions on how to submit comments are included in a related [Federal Register notice](#) also issued on the 7th. In finalizing the guidance document, the agency will consider the information received from the public.

New AHRQ Resource Can Help Prevent Patient Falls in Hospitals

Each year, between 700,000 and 1,000,000 people in the United States fall in the hospital. A fall may result in fractures, lacerations, or internal bleeding, leading to increased health care utilization. Research shows that close to one-third of falls can be prevented. Fall prevention involves managing a patient's underlying fall risk factors and optimizing the hospital's physical design and environment.

The US Department of Health and Human Services Agency for Healthcare Research and Quality (AHRQ) new online [toolkit](#) *Preventing Falls in Hospitals: A Toolkit for Improving Quality of Care* focuses on reducing falls that occur during a patient's hospital stay. This toolkit addresses overcoming the challenges associated with developing, implementing, and sustaining a fall prevention program.

The Toolkit is organized under six major areas that address hospital readiness, program management, choosing fall prevention practices, implementation, measurement, and sustainability.
