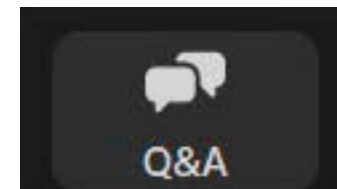
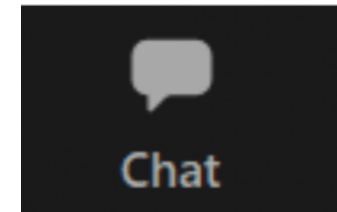

# Housing and Services Partnership Accelerator (HSPA) Opportunity

A unique opportunity to:

- Strengthen state Medicaid agency collaboration with agencies providing housing, aging and disability resources and programs.
  - Improve service delivery
  - Reduce potentially avoidable, high-cost services
- 

# Eligibility

- States with an approved Section 1115 demonstration covering housing-related services and supports for individuals experiencing or at risk of experiencing homelessness.
- States with an approved section 1915(i) state plan benefit covering housing-related supports for individuals experiencing or at risk of experiencing homelessness.
- One application per state.

- State needs assessment
- One in-person meeting in the Washington, DC, area
- 2 Peer-to-Peer Learning Tracks
- One-on-one state coaching sessions

# Benefits

-  Opportunity to develop and expand knowledgebase
-  Increased capacity to implement and strengthen strategies for providing housing-related activities, supports, and services
-  Access to technical assistance to support state activities
-  Implement a whole-of-government approach to address housing stability

# Team-based Application

## Required Core Team Members:

- State Medicaid Agency
- State and/or Local Housing and Homeless Agency/Organization
- State and/or Local Aging Agency/Organizations
- State and/or Local Disability Agency/Organization

# Additional Eligible Team

- Community Care Hubs (CCH)
- Single State Agency (SSA) for Substance Abuse Services and State Mental Health Agency (SMHA)
- State or Local Public Health Agencies
- Federally Qualified Health Centers (FQHCs)
- Managed Care Organizations (MCOs)
- Hospitals and Health Systems
- Behavioral Health Providers
- Community-Based Organizations (CBOs)
- Service Providers

# Application Process

- Letter of Intent submitted by **November 15, 2023**
  - URL for submitting: [<https://www.surveymonkey.com/r/LOIF>]
- Online application: due **December 1, 2023**
  - Worksheet available to draft responses to questions
  - Note word counts when drafting responses
  - Must include letter of commitment from the State Medicaid Director if the State Medicaid agency is not the applicant Must submit using the online questionnaire [<https://www.surveymonkey.com/r/BV52W7N>]
- Interview for high scoring states

## Selection Criteria (1 of 2)

- Evidence of Medicaid/Housing partnerships
- Clearly identified goals and detailed strategies
- Clearly articulated technical support needs – with specific expected outcomes
- Designated Medicaid agency staff member
- Identification of operational staff to serve as core team members
- Cross-sector representation of proposed team



## Selection Criteria (2 of 2)

- Alignment of goals with other relevant housing and service activities
- Alignment of technical support goals with other housing and service activities
- Capacity and readiness
- Commitment from State Medicaid Director
- Assurance that core team has time and resources for the full 12-month commitment
