US Access Board Webinar: Designing Accessible Crosswalks

This webinar reviews the requirements in the Public Rights-of-Way Accessibility Guidelines (PROWAG) for designing accessible crosswalks.

NCMM: <u>Don't Forget about the Sidewalk! The Role of Mobility Management Professionals and Coordination</u>
The FTA funded <u>National Center for Mobility Management</u> (NCMM) and colleagues from projects funded by the National Science Foundation conducted a webinar related to collecting data about the condition of

sidewalks. These data can inform mobility managers, community planners, transit providers, and ADA Coordinators about pedestrian access to community settings, including transit service.

NADTC: Resources on Rides for Employment for Older Adults and People with Disabilities

Transportation enables older adults and individuals with disabilities to access and sustain paid employment or volunteer work activities. Transportation options can vary considerably depending on the geographic area, this TA brief provides resources and best practices from the transportation industry that can assist in finding what's best for your area.

TRB Webinar: Alternative Services for ADA Paratransit Riders

Transit agencies are looking for ways to provide expanded mobility options to their ADA paratransit customers while reducing the overall cost. Alternative services accomplish both objectives. Alternative services are ondemand services provided by transit agencies as an alternative option. TRB hosted a webinar on Thursday, January 25, 2024 from 1:00 PM to 2:30 PM Eastern that included successful examples of alternative services.

N-CATT State of the Industry Demonstration

<u>The National Center for Applied Transit Technology</u> is accepting applications for our first-ever State of the Industry Tech Demonstration, which will take place in Grand Rapids, Minnesota, from July 22nd-25th. We will gather a small group of transit operators to study goMARTI: an automated vehicle (AV) deployment in a small-town setting. The demonstration aims to help agencies already considering AV deployment get a better understanding of how AVs can work in transit systems to see how or if it would work for their community. Safe Streets and Roads for All (SS4A) Grant Program is Now Accepting Applications!

The <u>Safe Streets and Roads for All (SS4A) Grant Program</u> funds regional, local, and Tribal initiatives through grants to prevent roadway deaths and serious injuries. Funds for the fiscal year (FY) 2024 SS4A grant program are to be awarded on a competitive basis to support planning, infrastructural, behavioral, and operational initiatives to prevent death and serious injury on roads and streets involving all roadway users, including

pedestrians; bicyclists; public transportation, personal conveyance, and micro-mobility users; motorists; and commercial vehicle operators.

USAging Announces Opening of Applications for Grants to Support Community Care Hubs

USAging's <u>Center of Excellence to Align Health and Social Care</u> (COE) is now accepting applications for grants to support innovation and infrastructure costs for up to 20 community care hubs (CCHs). The grants are intended to bolster CCH partnerships with health care organizations for coordinated access to and delivery of social care programs and services. They are part of the COE's effort to develop, expand, and support sustainable, high-functioning aging and disability CCHs and their networks of social care programs and service providers.

2024 Final Rule to Update Older Americans Act Regulations

On February 6, 2024, the Administration for Community Living (ACL) released a final rule to update the regulations for implementing its Older Americans Act (OAA) programs. The new regulations will take effect on March 15, 2024, but regulated entities have until October 1, 2025 to comply.
