AAA Longitudinal Research on Aging Drivers (LongROAD) Data User Guide

The aim of the AAA Longitudinal Research on Aging Drivers (AAA LongROAD) study was to understand the natural history, determinants, and mechanisms of driving behavior, safety, and related outcomes among older drivers. The project's goal was to enhance safe mobility among older adults by developing and conducting a prospective cohort study of older drivers and generate an extensive data and knowledge base that will fuel future research and decision-making regarding older driver safety and mobility. This document serves as the data user guide for the 5-year multi-site AAA LongROAD study of 2,990 drivers aged 65–79 at baseline.

Biden-Harris Administration Announces Nearly \$45 Million in Available Funds to Improve Bicyclist and Pedestrian Connectivity and Safety

The U.S. Department of Transportation's Federal Highway Administration (FHWA) announced today that it has opened applications for up to \$44.5 million in funding for projects that will strengthen safety and improve bicycling, walking and access to public transit in communities across the country. FHWA's new Active Transportation Infrastructure Investment Program (ATIIP), made possible by the President's Investing in America Agenda, is a competitive grant program that will focus on building networks of connected bicycle and pedestrian infrastructure improvements, including to better connect trail networks between communities. Input Opportunity: Ensuring Wheelchair Users Can Fly with Dignity

The U.S. Department of Transportation (DOT) is seeking public comments on a new proposed rule designed to ensure airline passengers who use wheelchairs can travel safely and with dignity. The proposed rule would set new standards for prompt, safe, and dignified assistance; require enhanced training for airline employees and contractors who physically assist passengers with disabilities and handle passengers' wheelchairs; and specify actions that airlines must take to protect passengers when a wheelchair is damaged during transport. <u>Comments can be submitted online, by mail or fax, or hand-delivered</u> through Monday, May 13, 2024.

Transportation Accessibility Research Round-Up

TRansit ACessibility Tool (TRACT): Developing a novel scoring system for public transportation system accessibility

This project created an open data platform on accessibility information. The research team reviewed the twenty-six public transportation systems with the most federal funding in 2020 and scored each system in six accessibility information categories. <u>Transportation for People with Disabilities and Older Adults During COVID-19: Lessons for Emergency</u> <u>Response (2024)</u>

This report from the Transit Research Board's Transit Cooperative Research Program examines lessons learned on transportation for people with disabilities and older adults during the COVID-19 pandemic and offers strategies for providing service during emergencies.

<u>Co-Designing Auditory Navigation Solutions for Traveling as a Blind Individual During the COVID-19</u> <u>Pandemic</u>

This study interviewed blind or low-vision individuals (BLIs) to understand the effects of COVID-19 on the travel of BLIs. The paper provided recommendations for increasing travel and COVID-19 knowledge of BLIs based on these interviews.
