#### **NCMM Ready-to-Launch Grants Open – Apply by 11/17/23**

The National Center for Mobility Management (NCMM) is now accepting applications for our [2024 Ready-to-Launch Grants](#). These planning grants offer up to \$75,000 in funding plus technical support from NCMM throughout the process. The goal of the grants is to enable multi-sector community teams to pilot promising mobility solutions, the development of which was inspired and informed by the results of community research. #### **N-CATT Tech Teams Applications Open**

The National Center for Applied Transit Technology (N-CATT) is [now accepting applications](#) for transit agencies to receive one-on-one technical assistance through the Center's Strategic Technology Technical Assistance Teams (STTATs). N-CATT will work with transportation providers to navigate a technology challenge or opportunity that results in a useful starting product for the agency, such as an implementation plan or ready-to-go technology solicitation. [U.S. Access Board Issues Final Rule on Public Right-of-Way Accessibility Guidelines](#). These guidelines inform federal, state, and local government agencies on how to make their pedestrian facilities, such as sidewalks, crosswalks, shared use paths, and on-street parking, accessible to people with disabilities.

[NYC set to become first large city to have rideshare fleet that is entirely zero-emissions or wheelchair accessible by 2030](#). The initiative, known as Green Rides, lays crucial groundwork in creating a cleaner and more accessible transportation system for NYC.

[New Google Maps features tackle obstacles to accessibility](#). Today, [Google announced](#) another expansion of its accessible navigation features, including wheelchair-accessible walking routes, updated Live View experiences for users who are blind, and a new identity attribute label for disabled-owned businesses.
