





## Overview

The Senior LinkAge Line is a free statewide service for older adults and their families. In partnership with Minnesota's Area Agencies on Aging, the Senior LinkAge Line provides information, assistance and connections to local services to help people make good decisions and remain independent in their communities.



# Senior LinkAge Line Services

The Senior LinkAge Line helps older Minnesotans and those providing care statewide.

- It helps Minnesotans plan for their future, stay in their homes, understand housing options and find services if life changes.
  - Program: Housing Options Counseling
- It connects people being admitted to a nursing facility with services and to help them live in the most integrated setting possible.
  - Program: Pre-admission Screening PAS
- It assists those leaving a facility or hospital to find the services and resources they need to return to their homes and communities.
  - Program: Return to Community RTC
- It navigates Medicare enrollment and supplemental insurance for beneficiaries statewide.
  - Program State Health Insurance Assistance Program SHIP

# Senior LinkAge Line Services

- It educates Minnesotans so they can protect themselves from fraud, waste and scams.
  - Program: Senior Medical Patrol SMP
- It provides assistance to people to help them afford their prescription drugs.
  - Program: Prescription Drug Assistance Program PAP
- It connects Minnesotans with services such as home delivered meals, chore services and transportation.
- It connects Minnesotans to financial and legal assistance, as well as advocacy through the Office of Ombudsman for Long-term Care.
- It helps people find the answers they need through self-service online tools.



6,253 Accepted Counseling 5,501 Declined Counseling 2018




# Housing counseling offered to anyone considering a move to Assisted Living Facilities by Race/Ethnicity

63% Female


36% Male


# **Pre-Admission Screening**

# Return to Community

- To help people live in the least restrictive setting of their choice
- \$8 million is provided annually in state funds
- We help an average 2,000 people a year develop a plan when leaving a nursing home to remain in their homes
- 10,000 referral calls a year to offer assistance
- Goal for 2022: Supporting caregivers



























# Populations: Return to Community

#### Ages of those Contacted




# Populations: Return to Community by Race/Ethnicity

# IRTC Initiative Goals

- Help seniors maintain their independence by keeping them in their homes with wraparound support services
- Integrate services through care coordination and management



# IRTC Initiative Goals

Reduce unnecessary facility placement, unnecessary hospital admissions and readmissions, and emergency department use



# **Key Elements**

- Service coordination at discharge
- Up to 90 days of intensive services

 Increasing access to person-centered planning


