





- •Since 1972 we've focused our efforts primarily on populations that have traditionally lacked legal protection such as women, people of color, LGBTQ+ individuals, and people with limited English proficiency.

Housing Issues Facing Older Adults





OAA mandate to serve older adults includes addressing housing instability

Title III-B of the Older Americans Act (OAA) provides funding so that legal assistance providers can "prioritize representation and advice that focus on the specific areas of law that give rise to problems that are disparately experienced by older adults with economic or social need."

Including:


- older adults experiencing cultural, social, or geographical isolation
- isolation due to racial or ethnic status, and
- those facing housing instability



Housing Issues Facing Low-Income Older Adults

- Increasingly Unaffordable Rents and Costs of Homeownership
- Lack of an Adequate Supply of Affordable Housing
- Increasing Disabilities/Lack of Physically Accessible Housing
- The Dual Burden of Paying for Housing and Care
- Increasing Care Needs: Models that integrate housing and services
- Hoarding

A Lack of Affordable Housing






Cost Burdens

OLDER ADULTS WITH COST BURDENS AT ALL-TIME HIGH



The Housing Affordability Gap is Growing, Especially for Lower Income Older Adults

Across Incomes, Significant Shares of Older Renters and Homeowners with Mortgages Face Housing Cost Burdens





Lack of Affordable and Accessible Housing

- 3.7 million older renter households whose income makes them eligible for federal housing assistance do not receive it.
- Older housing stock: Accessibility

Issues that Arise for Older Homeowners

- Can't afford mortgage, taxes and utilities
- Reverse Mortgages
- Predatory Lending Scams and other Equity Stripping Devices
- Tax Liens
- Mortgage Foreclosures
- Need for accessibility modifications

Issues that Arise for Older Renters

- Non-payment of Rent/eviction
- Disability/Reasonable Accommodations
- Hoarding
- Diminished Capability or Diminished Ability for Self-Care



Strategies for Keeping Older Tenants Housed

- Enactment of tenant protections: Good Cause, Rent Caps
- Early interventions to address housing and service needs
- Using reasonable accommodations to preserve tenancy
- Using source-of-income, fair housing, and other anti-discrimination protections to secure or keep housing
- Financial resources for rental assistance, home modifications
- Assisting with applications/barriers to subsidized rental assistance
- Eviction defense: connecting tenants with legal representation

Role of Legal Assistance





Why Should You Refer Clients for Legal Help?

- Landlords MUST go through judicial process and get court order to legally evict
- Without attorney, huge power imbalance
- •Eviction cases:
 - Landlords represented in around 81%-90% of cases
 - Tenants represented in around 3-10% of cases
- Legal representation is extremely effective
 - Tenants with full representation win or favorably settle eviction case as much as 96% of the time
- •Without representation, vast majority of tenants lose their housing



Right to Counsel

- Effectiveness of legal representation has led to Right to Counsel movement for eviction cases
- •<u>5 states, 17 cities, 2 counties with Right to Counsel legislation</u>
- •Examples: Maryland, Nebraska, Denver, Kansas City, Los Angeles County
- Delaware also has similar legislation (Right to Representation)



What Can Legal Aid Attorneys Do?

- Enforce client's legal rights and prevent eviction and housing instability
- Represent clients in court and administrative proceedings
- Attorneys can negotiate with landlords to settle case favorably for clients
 - Might mean clients stay in current housing
 - Might mean securing more time for clients to move out and find new housing



More on What Legal Aid Attorneys Can Do

- Request, negotiate reasonable accommodations for clients with disabilities so they can stay in or access housing
- File fair housing complaints with HUD, state civil rights agencies, and courts
- Address other legal issues intersecting with housing case
- Use information from individual cases to address systemic problems
- Provide trainings, community education



What Can Legal Aid Attorneys NOT Do?

- Cannot take every case (even in areas with right to counsel)
 - But will at least provide advice/referrals
- Go beyond scope of legal representation to directly help with nonlegal issues, such as:
 - Finding provider for behavioral health treatment
 - Housing search assistance
 - Submitting applications for public benefits, subsidized housing
- Provide ongoing support to help clients maintain housing stability



Tips for Referrals

- Develop relationships with local legal aid programs!
 - Warm handoffs increase likelihood that client's case will be accepted
- Don't wait to talk to legal aid and refer clients eviction cases move fast
- •Send documentation about case (notices, emails with landlord, etc.)
- •Especially important to refer clients with subsidized housing who might lose housing AND subsidy

- National Center for State Courts Map of Legal Aid Providers
- OAA-funded legal assistance providers (contracted through the AAA)
- LSC-funded legal aid agencies
- <u>LawHelp.org</u> (includes information on non-LSC legal aid agencies)
- •<u>P&A Agencies</u> (provide legal representation for people with disabilities)
- •FHIP (fair housing) agencies (not all provide legal aid, but those that do can provide legal representation in fair housing cases, like cases involving reasonable accommodations)



Working Together: How It Started

- Parallel outreach
- Overlapping issues: public benefits, health insurance, scams, utility shutoffs, housing, advance directives
- Old referral form difficult to use, no plan for PSLS to refer clients back to CCSI







How It's Going



- Streamlined referral process
- Point person on each end with authority
- Information sharing
- Aligned Goals:
 - Keeping clients in community settings
 - Client-centered/person-centered approach





Case Example: John

- Moving from homeless camp into public housing
- Referred to PSLS: Eviction notice—nonpayment of rent
- Several other issues identified: phone, SNAP benefits wrong, SSI benefit suspended
- Negotiated with HA for extended period to catch up on rent
- Shared information to correct benefits issues together


Key Takeaways

- Older adults face mounting and multi-faceted issues related to housing and housing instability.
- Legal assistance can provide a rights-focused presence to bridge the gap in justice for particularly low-income older adults.
