# **Key Takeaways: Strategies to Assess and Meet the Needs of Family Caregivers Learning Event**

## **Overview of Caregiver Assessments**

Kathy Kelly, Executive Director, Family Caregiver Alliance (FCA)

- Caregiver assessments are essential for understanding caregivers' unique circumstances, strengths, challenges, health, well-being, and support needs.
- Caregivers have three domains of needs: direct care, care planning, and caregiver wellness.
- Organizations can conduct assessments through home visits, online assessments, or self-administered online assessments.
- Assessments involve gathering information about both the caregiver and the care recipient, including environmental context, defined needs, barriers to caregiving, and existing supports.
- Caregiver support service interventions include programs and trainings aimed at reducing caregiver stress, loneliness, and depression, and those that enhance caregiving and communication skills.
- Organizations designing and implementing caregiver assessments should consider the cross-cutting principles aligned with the 2022 National Strategy to Support Family Caregivers.



## **Best Practices in Caregiver Assessments: Panel Discussion**

#### **Assessment Tools**

- Erdmann indicated that Wisconsin uses the <u>Wisconsin Family Caregiver Needs Assessment</u>, which includes a pre-survey and post-survey used to track changes in key areas over time.
- Switalski described Connecticut's <u>Caregiver Assessment</u> for OAA funded programs and the Connecticut Statewide Respite Care Program.
  - Assessment includes key domains and questions (e.g., depression screening, living environment, caregiver cognition, and behavioral needs questions) and uses a data collection system to capture and streamline data.
- Robison elaborated on current and future uses of caregiver assessments in other Connecticut programs, such as the Medicaid home and community-based services programs and the Money Follows the Person program.

#### Assessment Approaches

- Erdmann noted that Wisconsin uses their assessment tool to determine short-term needs that can be addressed immediately and emphasized the importance of letting caregivers tell their story and building rapport.
- Switalski shared that Connecticut uses similar assessment domains as Wisconsin and prefers conducting assessments in the caregiver's environment, with the care recipient, to best understand their needs.
- Robison emphasized the importance of capturing data in a way that allows for assessing changes over time for Connecticut.

### **Assessment Funding**

- Switalski and Erdmann shared Connecticut's and Wisconsin's strategies for:
  - Combining funding streams to support caregiver services, supports, and assessments include using a combination of OAA Title III-E (NFCSP) funds, statewide initiatives, and grant funds.
  - Leveraging staff from various programs, such as aging and disability resource center specialists and state respite care managers, can improve the efficiency of implementing assessments.

#### **Assessment Frequency**

• Bradford noted that Wisconsin conducts assessments during their first meeting with caregivers and follows up annually to determine changes in needs.

#### **Assessment Uses**

- Bradford and Switalski explained that the information gathered from Wisconsin's assessments help inform care plans, which are flexible based on caregiver needs.
- Robison added that Connecticut also uses the assessment to help inform care managers about whether the family would benefit from enrolling in a program that supports persons living with dementia.

## **NCSC TACC Caregiver Assessments Environmental Scan**

Salom Teshale, NCSC TACC, and Senior Policy Associate at the National Academy for State Health Policy (NASHP)

- The NCSC TACC is conducting a 50-state scan of caregiver assessments and a literature review of caregiver assessments and supports used in both NFCSP and NACSP.
- Early findings indicate the importance of training and guidance for effective delivery.
- States' processes to collect caregiver outcomes, assessment, and follow-up data vary.
- The NCSC TACC is developing technical assistance resources to be made available to programs implementing OAA caregiver programs.
