

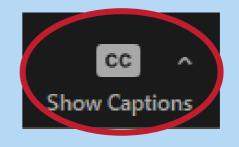

Opening Remarks from Administration for Community Living



What is the National Caregiver Support Collaborative?



Purpose: Greater recognition, support, and inclusion of the family caregivers served by the NFCSP (OAA Title III-E) and the NACSP (OAA Title VI-C) and greater alignment with other efforts to improve supports to family caregivers



Composition: Comprises the TACC and six grantees focused on key family caregiving priorities that will support implementation and advancement of the National Strategy to Support Family Caregivers



NCSC Target Audience: Aging Network

Target Audiences:

Older Americans Act (OAA) aging and tribal services networks, and applicable partners, such as:

- Area agencies on aging
- State units on aging
- Local service providers
- Title VI providers
- Native Hawaiian organizations
- Kinship organizations
- Disability service networks

Family Caregiver Populations Addressed:

- Family caregivers of older adults
- Family caregivers of individuals of any age with early onset dementia
- Older relative caregivers of children
- Older relative caregivers (including parents) of adults (age 18–59) with disabilities



NCSC Progress to Date



This is the first national scale capacity building effort in over 20 years for the NFCSP and NACSP.



The initiative is designed to improve alignment between the NFCSP and NACSP and other ACL initiatives to improve the lives of caregivers and care recipients.



Six NCSC grantees and the TACC have been developing actionable tools and resources to support the aging network.



Grantee Collaboration to Accelerate Progress

NCSC grantees work collectively by:

Sharing findings, research, and other critical data on family caregiving

Identifying opportunities for collaboration and alignment



National Strategy to Support Family Caregivers

All NCSC activities are grounded in and informed by the National Strategy, which consists of five goals:

Goals

- 1. Increase awareness of and outreach to family caregivers
- 2. Advance partnerships and engagement with family caregivers
- 3. Strengthen services and supports for family caregivers
- 4. Ensure financial and workplace security of family caregivers
- 5. Expand data, research, and evidence-based practices to support family caregivers



Introduction to the NCSC Technical Assistance and Coordinating Center



What is the TACC?

In addition to the work of individual grant projects, the TACC conducts cross-cutting TA activities, including:

- Serving as a resource for aging, kinship, and tribal caregiver support programs and networks (e.g., developing TA resources, responding to requests, and providing information)
- Identifying and disseminating best practices (Section 373 (e) of the OAA)
- Promoting and implementing the use of caregiver assessments by sharing caregiver assessment promising practices and developing a "create-your-own" caregiver assessment (Section 373 (j) of the OAA)
- Facilitating collaboration between grant projects (Section 373 (i) of the OAA) and dissemination of grantee resources
- Evaluating the effectiveness of all NCSC activities

More than 53 million family caregivers provide most of the support that makes it possible for older adults and people with disabilities to live in the community. The National Caregiver Support Collaborative (NCSC) is a multifaceted initiative to increase the recognition, support, and inclusion of family, kin, and tribal caregivers across the country, resulting in measurable improvements in the capacity of the network to assess caregiver needs, provide supportive services, collect data, and most importantly — support the well-being of caregivers and the people receiving care.

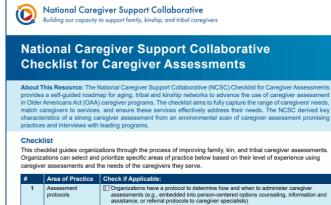

Checklist for Caregiver Assessments



1	Assessment protocols	[[] Organizations have a protocol to determine how and when to administer caregiver assessments (e.g., embedde into person-centered options counseling, information and assistance, or referral protocols to caregiver specialists) [[] Initial intake includes screening to identify caregivers, including intake into the No Wrong Door (NWD) system of access to supports
2	Person-centered considerations	The assessment process follows a person-centered approach and is completed with direct participation from the caregiver (note: timing of assessment should accommodate the caregiver's expressed eneeds) The assessment's tone is conversational and focused on relationship building between the assessor and caregiver The assessment process considers the needs of unique populations
3	Assessment components	When possible, the assessment is an evidence-based or evidence-informed tool ¹ The assessment has electronic capability to capture data and allows caregivers to access key outcomes from the assessment In the assessment is didactic: it includes education and resources as well as discussion of needs and desired outcomes The assessment is strengths-based: it builds on what is going well

Goal 1: Increase awareness of and outreach to family caregivers

Community Catalyst, Inc.



Project Objectives:

- Provide coaching and TA to 10 state-based family caregiving coalitions
- Educate and train a cohort of family caregivers to use their voices to bring change in their communities
- Identify best practices and apply the lessons learned from the work with state-based coalitions to generate greater awareness of family caregiving issues



Accomplishments:

- Engaged the caregiver community (e.g., integration of respite care into caregiver events, outreach to connect caregivers to resources)
- Established National Steering Committee representative of individuals with lived expertise, alongside nationally recognized experts
- Conducted baseline survey research on awareness of caregiving supports across the 10 states where our family caregiving coalitions are based

Goal 2: Advance partnerships and engagement with family caregivers

The Regents of the University of California, San Francisco (UCSF)



Project Objectives:

- Develop multimodal trainings for health care teams on how to integrate caregivers into person-centered care using evidence-based tools and practices
- Implement trainings across clinical settings (e.g., hospitals, clinics)
- Disseminate trainings nationally
- Evaluate impact of trainings on health care teams, including caregivers and care recipients



Accomplishments:

- Built a website and produced a video, including interviews with caregivers, to introduce the program
- Created Caregiver Training Billing Guides designed to help health care teams navigate reimbursement for caregiver training and education
- Launched the foundational course (online and live) and three supplemental courses for interprofessional care teams to learn how to identify, engage, and support caregivers

- Develop a Caregiver Services and Supports Action Guide Series (e.g., Respite Care, Emergency Preparedness)
- Launch a Caregiver Champion
 Collaborative
- Launch an Aging Network Caregiver Services and Supports Innovations Hub
- Launch pilot sites to spur innovation
- Conduct caregiver services and supports Conference Summits and Virtual Symposia



Accomplishments:

- Launched Caregiver Champion Collaborative in May 2024 with over 250 caregiving professionals
- Launched Innovations Hub call for program submissions in Fall 2024
- Completed final drafts of eight Action Guides
- Held in-person caregiving preconference at the Annual USAging Conference in July 2024

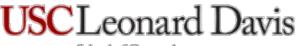

Project Objectives:

National Caregiver Support Collaborative

- Develop a learning collaborative of multidisciplinary experts and community partners to guide project activities
- Identify, curate, and disseminate caregiving planning resources through two comprehensive environmental scans
- Develop an informational clearinghouse to disseminate information and key products



Accomplishments:

- Built a learning collaborative (six partner organizations, a steering committee, and three workgroups)
- Engaged with steering committee and workgroups on product development
- Completed financial environmental scan; initiated systematic literature review
- Compiled products for inclusion in a USC-hosted website; the platform will be disseminated through the aging network

Goal 5: Expand data, research, and evidence-based practices to support family caregivers

National Alliance for Caregiving



Project Objectives:

- Develop a multidisciplinary and inclusive research network (The CARE Network)
- Develop a research agenda that synthesizes existing caregiving research initiatives
- Develop a learning program to increase awareness and capacity to engage
- Centralize uptake of consistent measures on family caregiving and evidence-based interventions



Accomplishments:

- Drafted and solicited feedback on National Caregiving Research Agenda
- Surveyed caregiving service providers to identify opportunities to promote engagement in research
- Began environmental scans and systematic reviews to identify data sources, common measures, and interventions in caregiving research

- Administered surveys
- Facilitated listening sessions and conducted key informant interviews
- Began developing pilot site funding opportunity

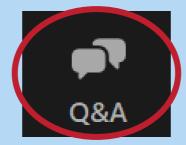

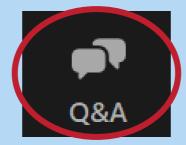
