About


Title VI programs are funded through Part A/B and/or Part C grants for the provision of nutrition, supportive services, and caregiver support services for American Indian, Alaskan Native, and Native Hawaiian elders.

The purpose of this guide is to help identify the many different ways that these funding options may be used to support Title VI operations.
