Goals, Strategies, and Activities

The overall purposes of this two-year grant are to:

- Significantly increase the number of participants in evidence-based selfmanagement education and support programs; and
- Implement innovative funding arrangements to support the proposed programs, while embedding the programs into an integrated, sustainable program network.

AgeOptions and its partners will:

- Increase capacity and improve infrastructure for chronic disease selfmanagement education (CDSME) programs to improve the health of older adults and adults with disabilities, with a focus on underserved populations;
- Implement a statewide data management system for CDSME programs, including a coordinated, bidirectional referral and tracking component to provide feedback to health care providers; and

 Embed programs into the routine operations of 3-5 health care systems and develop contracts for a sustainable statewide program.
