## Alison Barkoff Acting Administrator & Assistant Secretary for Aging

Alison Barkoff was sworn into office as the Principal Deputy Administrator on January 20, 2021, and currently is serving as Acting Administrator and Assistant Secretary for Aging. In this capacity, she provides executive direction, leadership, guidance and coordination for ACL programs nationwide and advises the

HHS Secretary on issues affecting individuals with disabilities and older adults.

Ms. Barkoff comes to ACL from the Center for Public Representation, where she served as Director of Advocacy. In that position, she led policy advocacy with federal agencies and Congress and legal advocacy nationally to advance community living and inclusion, including in the areas of healthcare, Medicaid home- and community-based services, employment, housing, and education. She led and participated in numerous coalitions with disability and aging organizations, including as co-chair of the Long-Term Services and Supports Task Force of the Consortium for Citizens with Disabilities. She has testified before Congress and the U.S. Commission on Civil Rights on disability rights and was appointed to serve on the federal Advisory Committee for Competitive Integrated Employment of People with Disabilities.

Ms. Barkoff previously served as Director of Advocacy at the Bazelon Center for Mental Health Law, where she worked on a range of disability, healthcare, education and civil rights issues. In earlier government roles, she served as Special Counsel for Olmstead Enforcement in the Civil Rights Division of the Department of Justice, leading efforts to enforce the rights of people with disabilities to live, work and fully participate in their

communities. She also worked with the Centers for Medicare & Medicaid Services within the Department of Health and Human Services on policies related to Medicaid home- and community-based services and with the Department of Labor on issues affecting the workforce providing in-home services. She is a sibling to an adult brother with developmental disabilities and been involved in disability advocacy her entire life. She received her undergraduate degree from Cornell University and her Juris Doctor from Emory University School of Law.



## Greg Link, MA Director of the Office of Supportive and Caregiver Services

Greg Link is the Director of the Office of Supportive and Caregiver Services with the Administration for Community Living/U.S. Administration on Aging, which oversees programs funded under the Older Americans Act (OAA), including Title III-B in-home supportive services, Title III-E National Family Caregiver Support Program as well as ACL's Alzheimer's disease programs. Greg and his team also

provide general oversight and technical assistance to the aging network on a range of program areas, including Information and Referral, family caregiver support programs and policies, housing, employment, transportation, LGBT aging, and Holocaust Survivors.

Before coming to ACL/AoA, Greg worked at the National Association of State Units on Aging where he provided technical assistance and training to states on family care giving, consumer direction, and transportation. Greg has also worked at the community level as a case manager and social services manager at Senior Friendship Centers in Fort Myers, Florida. There, he oversaw the social services staff and the delivery of services funded by the Older Americans Act, state funds and Medicaid waivers.

Greg holds a bachelor's degree in psychology from the University of Central Florida and a Master of Arts in Government from Johns Hopkins University.

Pamela Nadash is an Associate Professor of Gerontology at University of Massachusetts Boston, in the McCormack School of Policy & Global Studies and Fellow of the LeadingAge LTSS

Center@Umass Boston. Her work centers on policies that enable people with long term care needs to access the supportive services they need. This work includes a focus on financing of long term services and supports, nursing home quality, home and community-based services, and supportive housing; it also includes looking crossnationally at different countries' long term care financing and service delivery systems, as well as studying variations in policies and practices among states in the US; she also has a special interest in policies that support informed choice and the politics of aging. She sits on the Leadership Council of The National Consumer Voice for Quality Long-Term Care. Her work has been published in Health Affairs, Health Services Research, The Gerontologist, and The Milbank Quarterly. At UMass Boston, she teaches policy courses in the Gerontology PhD program and in the Management of Aging Services program.

Prior to academia, she worked for Thomson Medstat as consultant and has extensive experience conducting both qualitative and quantitative studies on aging and disability issues for nonprofits, including the Visiting Nurse Service of New York and the National Council on Aging. Her career also includes six years as at the Policy Studies Institute and the Consumers' Association in the UK. She earned her Ph.D. in Public Health and Political Science from Columbia University and has a master's in political theory from Oxford University and an undergraduate degree in philosophy from Bryn Mawr College.
