- 3. Develop and update business plans for Beacon Community Connections and the VIA network.
- 4. Create an operations manual based upon an established workflow process.
- 5. Design and develop data integration plans and projects between network members.

# **Grant Summary:**

Beacon is a 501(c)(3) non-profit whose mission is to collaborate with social service organizations, criminal justice agencies, healthcare providers, and other organizations to improve community well-being, particularly for older adults and people with disabilities.

As the NLE, Beacon has established an informal CIHN, referred to as the VIA network, over the eight parishes in the South Louisiana region of Acadiana. The VIA network will be governed through a network advisory council comprised of healthcare administrators, community-based organization leadership, and community stakeholders. Beacon provides many of the access functions of a broader No Wrong System (NWD) system or collaborates with the appropriate entities to complete the functions regionally as part of a statewide NWD system. Through this grant, the VIA network will deepen and expand its partner relationships to provide comprehensive and effective long-term services and supports to allow older individuals and individuals with disabilities to remain in their community. Anticipated outcomes include executed network partnership agreements and contracts, financial model cost-benefit analyses and reports, up-to-date business plans, a network operations manual, network data audits, and comprehensive data integration plan. Beacon has contractual relationships with both regional health systems as well as collaborative relationships with regional and state aging departments, healthcare organizations, social service agencies, and justice agencies to address the social determinants of health needs within the community.
